PURSUANT TO THE ORDER DATED 16<sup>TH</sup> APRIL, 2024 PASSED BY THE HON'BLE NATIONAL COMPANY LAW TRIBUNAL, CHANDIGARH BENCH ("HON'BLE NCLT") IN THE MATTER OF SCHEME OF ARRANGEMENT AMONGST INOX WIND ENERGY LIMITED AND INOX WIND LIMITED AND THEIR RESPECTIVE SHAREHOLDERS THROUGH VIDEO CONFERENCING:**

Pursuant to the directions of the Hon'ble NCLT, the meeting of the equity shareholders of the Company was held today, i.e., Saturday, 1<sup>st</sup> June, 2024, at 10:00 A.M. (IST) through Video Conference ('VC') ('Meeting'). The Meeting was conducted in compliance with the provisions of the Companies Act, 2013 ('Act'), read with the applicable general circulars issued by the Ministry of Corporate Affairs, Regulation 44 and other provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations'), other applicable SEBI Circulars and Secretarial Standard on General Meetings as issued by the Institute of Company Secretaries of India.

Mr. Dhritiman Bhattacharyya, Lawyer of the Company, on behalf of the Chairperson, welcomed all the members, Company's representatives and advisors of the Company present at the meeting.

Thereafter, he introduced Ms. Upma Chawdhry, Chairperson, Ms. Malvika Singh, Alternate Chairperson and Mr. Rahul Jogi, Scrutinizer, all of whom were appointed for the meeting by the Hon'ble NCLT.

73 Members holding 69.55% equity shareholding in value of the Company have attended the NCLT convened Meeting through VC. Since the requisite quorum was present at the meeting as per the directions of the Hon'ble NCLT, the Chairperson called the meeting to order.

Mr. Dhritiman Bhattacharyya further informed that pursuant to the order of the Hon'ble NCLT and the applicable Circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India, the Company has convened this NCLT convened meeting through VC without the physical presence of the members at a common venue for the purpose of considering, and if thought fit, approving with or without modification(s), the Scheme of Arrangement between Inox Wind Energy Limited and Inox Wind Limited and their respective shareholders, pursuant to the provisions of Sections 230 to 232 and other applicable provisions of the Companies Act, 2013 including rules and regulations made thereunder ("Scheme").

Mr. Dhritiman Bhattacharyya briefed the members about the proposed Scheme. Thereafter, the following businesses were transacted at the NCLT convened meeting of the Equity Shareholders of the Company as set out in the Notice:
