### INDEPENDENT AUDITOR'S REPORT

To the Members of Sarayu Wind Power (Kondapuram) Private Limited

Report on the Audit of the Financial Statements

### Opinion

We have audited the financial statements of Sarayu Wind Power (Kondapuram) Private Limited ("the Company"), which comprise the balance sheet as at 31st March 2022, and the statement of Profit and Loss, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2022, and loss, changes in equity and its cash flows for the year ended on that date.

### **Basis for Opinion**

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## **Emphasis of Matter**

We draw attention to the Note 5 of financial statements which states that the Company has made the payment to State Government of Andhra Pradesh for Kurnool Project of 304 MW amounting to Rs. 110.28 Lakh in earlier years. Due to Change in State Government Policy for wind farm Development, the project has been suspended till any further notification/circular by the State Government. The company is waiting for reverse bidding/tender on State Transmission Utility by the state Governments, so as to utilize the capacity of 250 MW at the earliest. In the opinion of the management, Company will able to recover the amount when project will continue.

We draw attention to Note 20 of the financial statement which describes the management's assessment of the impact of the outbreak of Covid-19 on revenue. The management believes that no adjustments are required in the financial statements as there is no impact in the current financial year. However, in view of highly uncertain economic environment and its likely effect on future revenues due to Covid-19, a definitive assessment of the impact on the subsequent periods is dependent upon circumstances as they evolve.

Our report is not modified in respect of above matters.

The Company's Board of Directors is responsible for the other information. The other information comprises the information included in Board's Report including annexures to Board's Report, but does not include the financial statements and our auditor's report thereon.
